DISPOSAL OF SHARES BY THE SUBSTANTIAL SHAREHOLDER

This announcement is made by Sheng Tang Holdings Limited (the “**Company**”) pursuant to Rule 17.10(2) (a) of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

DISPOSAL OF SHARES BY THE SUBSTANTIAL SHAREHOLDER

The board (the “**Board**”) of directors of the Company (the “**Director(s)**”) was informed by Advanced Pacific Enterprises Limited (“**Advanced Pacific**”), a substantial shareholder (as defined in the GEM Listing Rules) of the Company, that on 17 April 2025 (after trading hours), it had entered into sale and purchase agreement with Mr. Li Mung Tat (“**Mr. Li**”), pursuant to which Advanced Pacific agreed to dispose of and Mr. Li agreed to purchase 100,000,000 shares of the Company (the “**Shares**”), representing approximately 7.94% of the total issued share capital of the Company as at the date of this announcement, at the consideration of HK\$17,000,000 (the “**Disposal One**”).

On the same date, the Board of Directors was informed by Advanced Pacific, that on 17 April 2025 (after trading hours), it had entered into sale and purchase agreement with Ms. Zhang Pei Pei (“**Ms. Zhang**”), pursuant to which Advanced Pacific agreed to dispose of and Ms. Zhang agreed to purchase 100,000,000 Shares, representing approximately 7.94% of the total issued share capital of the Company as at the date of this announcement, at the consideration of HK\$17,000,000 (the “**Disposal Two**”).

Advanced Pacific further reported that, to the best of its knowledge, Mr. Li, save from his current holding of 36,000,000 Shares before the completion of Disposal One, is independent of and not connected with the Company and its connected persons (as defined in the GEM Listing Rules). Similarly, Advanced Pacific indicated that Ms. Zhang, save from her current holding of 18,100,000 Shares before the completion of Disposal Two, is also independent of and not connected with the Company and its connected persons.

As of the date of this announcement, Advanced Pacific is wholly and beneficially owned by Mr. Heung Chung Sum, an executive Director and the chairman of the Board.

Upon completion of Disposal One and Disposal Two, Advanced Pacific will hold approximately 2.82% of the total issued share capital of the Company and will cease to be a substantial shareholder (as defined under the GEM Listing Rules). Mr. Li will hold 10.79% of the total issued share capital of the Company, becoming a substantial shareholder. Ms. Zhang will hold approximately 9.37% of the total issued share capital of the Company.

The Board does not expect the disposal of Shares by Advanced Pacific to have any adverse effect on the business operations of the Group.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
